If melted Mylar or balloon material has damaged any of the inventory or the "A" frame message board, full retail price will be billed to the client's credit card.

Our display items **WILL NOT** safely support the weight of a child or adult leaning, sitting, or playing on it. Please discourage all persons from playing on or around the display.

5) We encourage you to pose next to the display to take photographs of your celebration. However, please **DO NOT** pull the critters from the ground.

6) Please *protect our inventory* from any damage that might be caused during transportation, set-up, removal or flying debris from lawnmowers, dogs, etc. Contact with string trimmers may cause damage as well.
